Guidelines for preparing and accepting research articles for publication in the Afghanistan Research Journal of Herat University

1. Introduction

Herat University International Journal (Journal) is a scientific-research journal that works in both natural sciences and social sciences. The journal welcomes the submission of articles by all researchers. This journal is prepared in accordance with international standards and all articles published in it must be in accordance with accepted scientific standards and criteria. The journal will not consider submission of an article that has already been published elsewhere or accepted for publication.

2. The types of research articles that are accepted for publications in this journal. The Journal accepts the following research articles:

- 1. Scientific research articles
- 2. Promotional articles
- 3. Articles and case studies
- 4. Short scientific reports

3. Guide to preparing articles

The following is a guideline for preparing scientific articles:

3.1 Scientific-research article

A research paper should not exceed 7,000 words and 20 pages.

3.1.1 Promotional articles

Promotional articles should not exceed 5000 words.

3.1.2. Articles and case studies

Case studies should not exceed 1000 words

3.1.3. Short scientific reports

Short scientific papers should not exceed 1000 words. A short report is written about a new scientific finding which was not investigated before. Writing a scientific report after completing the research cannot prevent a stronger and more complete scientific article.

3.2 Guidelines for preparing scientific articles

The scientific article in social sciences should be written in one of four languages: Persian, Pashto, Arabic and English. The distance between the lines is double-space and margin at the top, bottom, right and left sides should be 3 cm.

3.2.1 Title page

The first page of the article should contain the title of the article (maximum 12 words). In the continuation of the first page, the names of the authors, their field of study, duty and place of work should be stated in detail. In the continuation of the first page, the names of the authors, their field of study, duty and place of work should be stated in detail.

The name of the principal author along with the contact number and email address (preferably institutional email address) should be mentioned.

3.2.2 Abstract

The second page is dedicated to abstract. The abstract should be written structurally and should not exceed 250 words. In the structural abstract, the problem / topic design sections, method, findings and final result are written clearly and separately.

After the abstract, three to five keywords are mentioned that can be used to find and index an article.

3.2.3 Main article

The main text of scientific research articles should be arranged in the order of the following titles:

- 1. Introduction (Includes problem statement, background and purpose of the research);
- 2. Hypothesis (quantitative approach) and research question(s);
- 3. Research methodology
- 4. Findings
- 5. Conclusion
- 6. References

3.2.3 Tables

Each table must be submitted separately to the journal in a separate file with its title. All tables must be numbered clearly and their numbers must be mentioned in the original text. Details and data descriptions of a table should be clearly written at the end of the table. The table title and the description below it should be double-spaced.

3.2.4 Graphs, images, diagrams

Graphs, images, and diagrams should be submitted separately in separate files with the title of the journal. The names of the graphs, images and diagrams are written below it. The descriptions of each should be written in detail at the end of it in double-spaced form.

3.2.5 References

The sources that have been used or mentioned in the preparation of the text of the article should be clearly stated in the text and at the end of it. The journal uses the APA referral method. Inside the text, the author's name, year of publication and page number are mentioned in parentheses, and at the end the sources are arranged in alphabetical order. The journal encourages all authors to use endnote software to submit their articles. The Journal will not accept articles that are not arranged according to the APA referral method or if the referral has spelling and technical errors.

APA referral guidelines are mentioned in the appendix.




